WHEREAS, a Declaration of Covenants for TABERNA, PHASE I, SECTION I as those lots appear in Map Book 61, at Page 8 was recorded in Book 1717, at Page 295 and a Declaration of Covenants for TABERNA, PHASE I, SECTION II as those lots are shown in Map Book 62, at Page 38 was recorded in Book 1790, at Page 257, and TABERNA, PHASE II as those lots are designated in Map Book 656, at Page 83 which Declaration is in Book 2072, at Page 165, and PHASE III which map is recorded in Map Book 67, at Page 12 and the Declaration recorded in Book 2191, at Page 363;

AND WHEREAS, it has been determined by the undersigned persons together with the Developer (Declarant) of PHASE II and PHASE III that it would be in the best interest of all parties to this Amendment that PHASE I (SECTION I and SECTION II), PHASE II and PHASE III join togetherinto a common owner's Association for the purpose of maintaining the entrance ways and the berms associated with all three phases of the subdivision to protect the values, safety and welfare of the properties and owners of lots in the various sections and phases.

AND WHEREAS, ROBERT D. PARROTT, as the Developer and Declarant of Phase II and Phase III has formed a non-profit corporation in the name of TABERNA SECTION III HOMEOWNERS

ASSOCIATION, INC. and has subjected all of the lots in Phase III to the Articles of Incorporation,

Declaration and By-Laws as established for that phase. Owners in Phase III and their lots which they have

purchased have been previously subjected to the Articles of Incorporation, By-Laws and Declaration of

TABERNA SECTION III HOMEOWNERS ASSOCIATION, INC. and by way of acceptance of their

various deeds have agreed to be members of the homeowners association and abide by its rules, By-Laws and
regulations.

Those persons executing this Amendment to Declaration of Covenants, Conditions and Restrictions do hereby voluntarily by way of their execution of this document agree to subject their individual lots to all of the provisions of the Articles of Incorporation of TABERNA SECTION III HOMEOWNERS

ASSOCIATION, INC. which is recorded in Deed Book 2243, at Page 512, together with the By-Laws which are recorded in Book 2560, at Page 314 of the Pitt County Registry and will subject their lots to all the rules and regulations and By-Laws.

HENCEFORTH and after the recording of this document, all of the lots in which owners have executed this document shall always in the future be subject to the Declaration of Covenants for Phase III, Articles of Incorporation and By-Laws for TABERNA SECTION III HOMEOWNERS ASSOCIATION, INC. and will be subject to their rules and regulations, including the payment of homeowner's dues as established in those documents.

All parties hereto understand and agree that failure to pay the required and necessary dues to the Homeowner's Association will allow the Homeowner's Association to assess the unpaid lot and lot owner accordingly. The Homeowner's Association shall also have the right to file a lien for all sums assessed and unpaid in the Office of the Clerk of Superior Court and to enforce the lien pursuant to the provisions of North Carolina General Statute 44A.
