YARD MAINTENANCE

It's that time of year, the primary elections are in May and political signs are going up. Please remember that any signs other than "For Sale" signs are not allowed in our neighborhood according to our covenants under Article V, Section 12.

In addition to keeping yards free of political & other signs, don't forget to keep them mowed and looking nice! Under Article 6, Section 22 of our covenants, grass should be no longer than 6" and yards should be kept free of weeds and other debris.

PARKING

We continue to get parking-related complaints. Please be considerate of your neighbors and **do not block their driveways or block any part of the sidewalk** when parking your car. If you notice any cars blocking your driveway or the sidewalk you can report them directly to city code enforcement at (252) 329-4522. Long-term street parking is also not allowed according to our covenants and City of Greenville code.

BUDGET UPDATE

METRONET

COVENANTS REMINDERS

- Please be aware that **basketball nets** are not allowed on the streets, both under Article V, section 18 of our covenants and by City of Greenville code.

- Please also be aware that street parking including **vehicles**, **RVs**, **trailers**, **or boats** is prohibited by Article V, Section 18 of our covenants and by City of Greenville code.

-The restrictions for fences can be found in Article 12, Sections 21 and 24 of our covenants. Shed restrictions can be found in Article 12, Sections 5 and 24. Please remember to get permission for **all fence and shed installations,** as well as any other architectural changes, by sending your requests to Amber at <u>amber@russellpm.com</u>
