## AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR THE WESTHAVEN SOUTH SUBDIVISION, SECTION 2

THIS AMENDED DECLARATION, made on the date hereinafter set forth by COOPER ISLAND DEVELOPMENT, LLC, a North Carolina Limited Liability company, with its principal offices in Pitt County, North Carolina, hereinafter referred to as "Declarant or Owner" and, Prospective Purchasers and all current owners of lots in Westhaven South Subdivision, Section 2 a residential subdivision located in Pitt County, North Carolina.

## <u>W I T N E S S E T H</u>:

WHEREAS, there was heretofore recorded a certain Declaration of Covenants,
Conditions and Restrictions running with the land for Westhaven South Subdivision, Section 2
which is recorded in Book 3666 Page 501 of the Pitt County Public Registry; and,

WHEREAS, the covenants recorded in Book 3666, Page 501 referenced Map Book 82, Page 167 and listed the lots set forth on said plat; and,

WHEREAS, the Declarant had an amended map prepared and recorded that added two additional lots, namely lots 41 and 91 which were not shown on the initial plat; and,

WHEREAS, the Declarant wishes to correct the legal description provided in the covenants recorded in Book 3666, Page 501 to include Lots 41 and 91; and,

NOW, THEREFORE, Declarant hereby impresses all of the properties described hereinafter shall be held, sold and conveyed subject to the restrictions, covenants, and conditions recorded in Book 3666, Page 501, Pitt County Registry and which shall run with the real property and be binding on all parties having any right, title, or interest in the following described properties or any part thereof, their heirs, successors and assigns, and shall inure to the benefit of each owner thereof, to wit:

Being all of Lots 22, 23, 24, 25, 26, 27, 30, 31, 32, 33, 34, 35, 36, 37, 38, 39, 40, 41, 91, 92, 93, 94, 95, 96, 97, 98, 99, 100, 101, 120, 121, 122, 123, 124, 125 and 126 of Westhaven South, Section 2 as shown on that map recorded in Map Book 82, Page 167 and as amended in Map Book 83, Page 4 of the Pitt County Registry.
