I also understand all construction must comply with the Association governing documents and city/county codes. The BRHOA Board does not override the city/county codes and the approval from the BRHOA Board is not an approval by the city/county. I agree to obtain necessary city/county permits prior to commencement of any work.

I understand failure to start or complete the improvement within 90 days from the Board approval date shall result in withdrawal of approval unless an extension is requested and approval is provided in writing.

I understand that approvals for seasonal (annual) modifications expire 9 months from the date of approval.

I agree not to alter existing drainage patterns on my lot without express approval of the Board.
